Re: RoHS Declaration of Conformity (Directives 2011/65/EU and 2015/863/EU)

The Delegated Directive 2015/863/EU (RoHS III), which amends Directive 2011/65/EU (RoHS II), imposes limits on the levels of certain substances in electrical and electronic equipment. These substances are listed below and in Annex II (Restricted substances referred to in Article 4 (1) and maximum concentration values tolerated by weight in homogeneous materials):

SUBSTANCE	THRESHOLD	SUBSTANCE	THRESHOLD
Lead	0.1%	Polybrominated Diphenyl Ethers (PBDE)	0.1%
Mercury	0.1%	Bis (2-ethylhexyl) phthalate (DEHP)	0.1%
Cadmium	0.01%	Butyl benzyl phthalate (BBP)	0.1%
Hexavalent chromium	0.1%	Dibutyl phthalate (DBP)	0.1%
Polybrominated biphenyls (PBB)	0.1%	Diisobutyl phthalate (DIBP)	0.1%

The enactment of the subsequent Delegated Directives entails the amendment of Annex III (in relation to applications exempted from the restrictions referred to in Article 4, paragraph 1) and Annex IV (applications exempted from the restriction referred to in Article 4, paragraph 1) of the RoHS Directive.

Some of the exemptions introduced relate to Lead, the only substance on the list that is present in OMT Group products:

- **6 (a):** Lead as an alloying element in machining steel and galvanised steel containing up to 0.35% lead by weight
- **6 (b):** Lead as an alloying element in aluminium containing up to 0.4% lead by weight
- **6 (c):** Copper alloy containing up to 4% lead by weight

Based on the above, the OMT Group hereby declares that its products comply with the limits imposed by Annex II of Directive 2011/65/EU (RoHS), and that the following items / components are covered by the exemptions listed in Annex III of Directive 2011/65/EU:

- **Steel items / components: Exemption 6 (a)**
- **Aluminium items / components: Exemption 6 (b)**
- **Brass items / components: Exemption 6 (c)**

Any changes not authorised by the OMT Group that are applied to any of its products after supply to your company, will not be covered by this declaration.
